

Dana Mitra Gambut Indonesia (Indonesian Peatland Partnership Fund)



Overview

DMG-Indonesia is partnership fund governed by Wetlands International, designed to support projects in community-based peatland conservation, restoration and sustainable development.

DMG-Indonesia is endorsed by the Indonesian Peatland Restoration Agency (BRG) to ensure optimal complementarity and appropriate integration with government plans and actions.

The projects that DMG-Indonesia supports will contribute to the national goal for peatland restoration (2.4 million hectares by 2020). It will focus on 5 provinces namely Riau, Jambi, South Sumatra, West Kalimantan and Central Kalimantan which is part of 7 priority provinces of BRG.

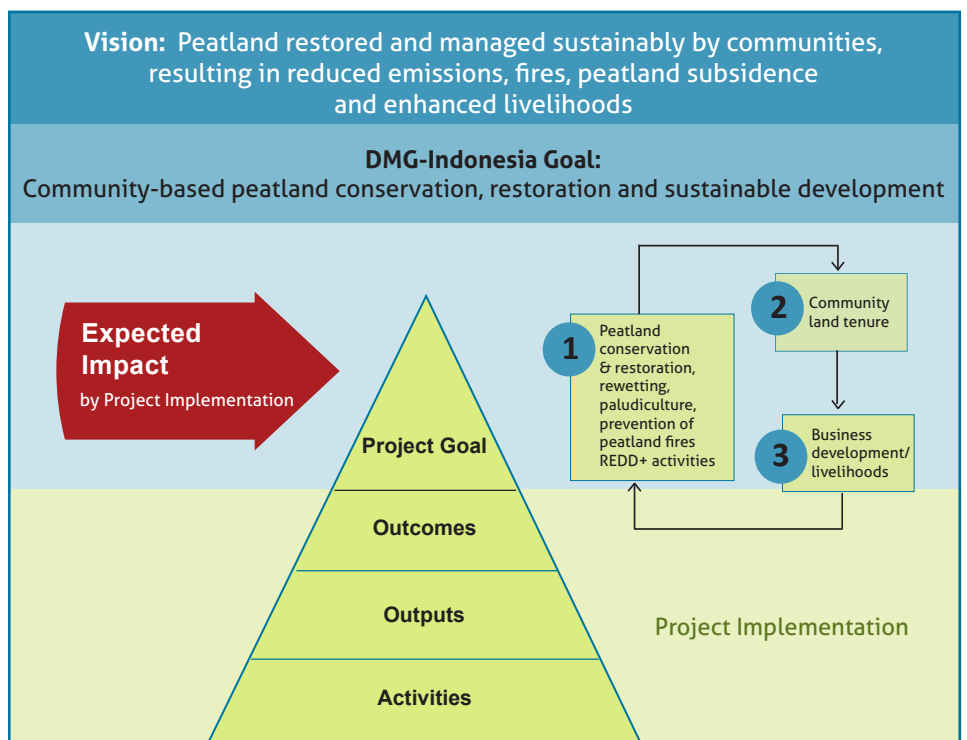
How do we work?

It operates through calls for proposals with clear objectives, procedures and progress monitoring. Each grant will be maximum of Rp. 300 million for a

maximum duration of 24 months project implementation.

In addition to funding, DMG-Indonesia also provides training and technical assistance on project implementation, general and technical issues related to peatlands, monitoring and

evaluation, project financial management, awareness raising and knowledge management to its grantees. Each project will be documented for accountability, to build knowledge, experience and lessons-learned.



Steering Committee

DMG-Indonesia is advised by a Steering Committee with representatives of Indonesian Peatland Restoration Agency (BRG), Ministry of Environment and Forestry and other non-governmental organisations involved in peatland conservation, restoration and sustainable development in Indonesia.

Dr. Dohong is a peatland expert, working as Deputy 2 (Construction, Operation and Maintenance) with BRG. His previous work includes engagements with: Wetlands International, AusAID, Global Environment Centre, Kalimantan Forest and Climate Partnership, and lecturer at Palangkaraya University.

Erna is a Partnership Director, at Directorate General of Social Forestry and Environment Partnership (PSKL), Ministry of Environment and Forestry (MoEF). PSKL has the task of organizing the formulation and implementation of policies in the field of community participation in forest management, community forest management and environmental partnerships.

Nyoman is a Director of Wetlands International Indonesia. He has over 20 years experience in peatland conservation. He is member of many working groups focused on wetlands, including BRG, MoEF and Badan Informasi Geospasial, and lecturer on wetlands management in various universities in Indonesia.
